Timeframe of service	<p>The gaming devices shall be registered and the gaming devices data shall be amended, supplemented or removed within 7 working days of receipt of the request.</p> <p>The gaming device type shall be registered in the register within 7 working days of the date of the decision of the Control Authority to approve the gaming device type.</p> <p>Registry data shall be made available to the applicant within 20 working days of the launching of the administrative procedure.</p>
5.	Fees of service	<p>The sate fees:</p> <p>1. Registration of a gaming device also of a gaming device to be used for training purposes into register – 11 EUR.</p> <p>2. Amending or supplementing of register data – 8, 60 EUR.</p>

Description of process for obtaining a service	<p>The register is a state register whose objects are the types of gaming devices approved by the order approved by the Government of the Republic of Lithuania, gaming devices operated in the Republic of Lithuania, gaming tables (hereinafter - gambling devices) and legal persons operating or wishing to operate gambling devices to be registered in this register in accordance with the procedure established by laws and other legal acts.</p> <p>Purpose of the register - to collect, store, process, systematize, store, use and provide data on the types of gaming devices operated in the Republic of Lithuania and companies operating it, to the state and municipal institutions and bodies, state registers, to other legal and natural persons in accordance with the procedure established by laws and other legal acts.</p>
8.	List of documents to be submitted to obtain a permit	<ol style="list-style-type: none"> 1. Request of the form established by the Gaming Control Authority under the Ministry of Finance of the Republic of Lithuania (hereinafter - the Control Authority). 2. Before starting to operate the gaming devices and operating gaming devices registered in the register and wishing to amend or supplement the data specified in Clauses 14.2 and 14.3 of the Lithuanian Gambling Register Regulation (hereinafter - the Regulation), the person shall submit documents confirming the data specified in Clauses 14.2 and 14.3 of the Regulation. 3. A fixed state fee shall be paid for the registration, amendment or supplement of the register data.
